



**Payment Terms:** Full payment for exhibits and sponsorships is due at contract signing. Checks should be made to AFS. Wire transfers may be received *If paying by wire transfer, please add \$40 for wire fee.* 

**Use of Space:** (1) No exhibitor shall assign, sublet, or share the whole or any part of the space allotted without the knowledge and consent of AFS. (2) AFS does not endorse the products or services of the companies who exhibit during the Conference and Expo. (3) AFS shall have the right to require dismantling of an exhibit or part of an exhibit which in their opinion is not suitable to or in keeping with the character and purpose of the Conference and Expo.

Assignment of Space: Space is assigned at the discretion of AFS. No space is assigned without the official contract and full payment of the exhibit fee.

**Insurance:** Exhibitors participate at his/her own risk. Exhibitors can obtain insurance coverage at their own expense for risks during participation at the event. The organizers accept no responsibility for exhibits.
